EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY 0800 243 622

IF THIS HAPPENS DO THIS

Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Collect spill. Deal with all spillages immediately. Contain the spill Recover spilt product I then transfer the recovered spilt material to a properly labelled drum that can be closed. Minimise run-off into drains or waterways If contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.
Fire	Call the Fire Service: Dial 111. Vapours may be toxic. Self-contained breathing apparatus required; chemical suit recommended. Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide. Do not allow contaminated run-off to enter drains or waterways.

FIRST AID

24 HOUR ADVICE IN A FIRST AID EMERGENCY 0800 POISON (0800 764 766)

If Swallowed:	Immediately call a Poison Centre or doctor. Rinse mouth with water. Do NOT induce vomiting. Get medical advice.
If in Eyes:	Hold eyelids apart and rinse the eye cautiously for at least 15 minutes. Remove contact lenses, if present and easy to do, continue rinsing. Contact a Poisons Centre or doctor for advice.
If on Skin:	Immediately take off contaminated clothing and flush skin and hair with running water. Continue for at least 15 minutes. Get medical attention if irritation or rash occurs.
If Inhaled:	Remove patient to fresh air and keep at rest in a position comfortable for breathing. If experiencing respiratory symptoms contact a Poisons Centre or doctor immediately.

STORAGE AND SEGREGATION SUMMARY

Storage: Store securely in original container, tightly closed and in a dry, cool, well-ventilated area away from foodstuffs, seeds, fertilisers and animal/human health products.
